## MOTION FOR SERVICE BY PUBLICATION ON DEFENDANT TONY TINDERHOLT

#### TO THE HONORABLE JUDGE OF SAID COURT:

Plaintiff asks the Court to authorize service by publication on Defendant Tony Tinderholt. This is a suit for money damages resulting from injuries received after an automobile accident caused by intoxication. The Defendant was covered by liability insurance at the time of the accident.

The residence of Defendant Tony Tinderholt is currently unknown. Attempts to obtain personal service, as outlined below, have been unsuccessful.

The incident made the basis of this suit occurred on or about the 13<sup>th</sup> or 14<sup>th</sup> of April 2000. Defendant Tony Tinderholt was an employee, and/or representative of JRAF Enterprises Inc. d/b/a The Horseman Club and/or JRAF Enterprises Inc. d/b/a Circle A Ranch. Defedant Tony Tinderholt was a manager of Defendant The Horseman Club. While upon the premises of Defendant The Horseman Club, employees, agents and representatives of Defendant The Horseman Club served and/or provided alcoholic beverages to Plaintiff who was under the legal drinking age. At the time when said alcoholic beverages were served and/or provided to Plaintiff was apparent to the providers that Plaintiff was obviously intoxicated to the extent

that he presented a clear danger to himself and others. After leaving Defendants' premises, Plaintiff drove and operated a motor vehicle. While operating said motor vehicle, he was unable to maintain control of the motor vehicle due to his intoxication. The motor vehicle Plaintiff was driving collided into a curb, causing him severe injuries.

Plaintiff's counsel ran a search on Publicdata.com, a fee for service on-line database containing the addresses of Texas drivers. See Exhibit "A." This search revealed this address for Defendant Tony Tinderholt 4438 Harlanwood Dr., 213 N, Fort Worth, Texas 76109. Service was attempted on Defendant Tony Tinderholt through a private process server at 4438 Harlanwood Dr., 213 N, Fort Worth, Texas 76109, the address listed as Defendant Tony Tinderholt's address on his Texas driver's license. Service was unsuccessful.

Plaintiff's counsel has attempted to locate Defendant Tony Tinderholt through various on-line databases and information sources. See Exhibits "B" and "C." As a result of the online searches, service was attempted on Defendant Tony Tinderholt at two other addresses: 1.) 1008 7<sup>th</sup> Ave., Camanche, Iowa 52730 and 2.) 847 Gateway Ave 11, Clinton, Iowa, 52732.

An on-line search of the Clinton and Camanche, Iowa areas turned up no current telephone listings for those addresses. Plaintiff's counsel attempted to locate Defendant by searching for every Tinderholt in Iowa to no avail.

Plaintiff asks the court to authorize service by publication on Defendant Tony

Tinderholt.
